After successful completion of the prescribed training within a period of one year and upon submission of proper certification for the same, the appointment order will be issued to them by the respective Cooperative Institution. Failure in completion of the prescribed training within a period of one year result in automatic cancellation of the particular candidate's selection.

The selection of candidates is purely provisional subject to the outcome of writ petitions No.15771 of 2022, 22135 of 2022 pending before the Hon'ble High Court of Madras and other cases if any, relating to this recruitment, filed before the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
