The admission to certificate verification and oral test is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her

online application in respect of Age, Educational Qualification, Cooperative Training, Communal category, PSTM etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to oral test. If he/she does not produce the required certificates or if he/ she does not satisfy the eligibility criteria, his/ her online application will be rejected and his/ her provisional admission to oral test will be cancelled and he/she will not be admitted to the next stage of selection process. Mere inclusion of the Register Number of candidates in the list does not confer any right on the part of candidate for participation in Oral test.

NOTES:

- 1 Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for next stage of selection.
- 2 The admission of candidates to oral test/CV and OT is provisional subject to verification and acceptance of the claims in their online applications towards Age, Educational Qualification, Community, Cooperative Training, PSTM status etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to oral test will be cancelled and they will not be admitted to next stage of selection.
- 3 Candidates who have been admitted provisionally to the oral test/CV and OT are hereby advised to attend the oral test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.

The candidates are also advised to attend the interview with all noted below documents in original and one set of photocopies (Xerox) of all documents with Self attested without fail. Failure to produce even any one of the essential documents at the time interview will result their non-admission to the interview.

- a. Call Letter with **two passport size photos** of the Candidate.

- b. 10th Pass Certificate.
 - c. 12th Pass Certificate.
 - d. Under Graduate Degree Certificate.
 - e. Community Certificate.
 - f. Cooperative Training/Qualification Certificate.
 - g. Destitute widow Certificate (if applicable)
 - h. Differently Abled person Certificate obtained from the competent Authority. (if applicable)
 - i. Person Studied Degree in Tamil Medium (PSTM Certificate)(if applicable)
 - j. Ex-Serviceman Certificate. (if applicable)
 - k. If employed, NOC from the Concerned Authority.
- 4 The candidates who have appeared for written examination and whose register numbers are not found in the above list have not been admitted to the oral test/CV and OT.
- 5 The physical appearance of the candidate for the interview is compulsory. If the candidates absent themselves for interview, they will not be considered for next stage of selection.
- 6 Final Result of this examination are subject to the outcome of writ petitions **No.15771 of 2022 and 22135 of 2022** pending in the Hon'ble High Court of Madras which is related to the District Recruitment Bureau.
